## WHAT WE DID

### 1 Research Legal Adult-Use Marijuana Businesses and the Options Available to the Town.

Marijuana business types - eight legal establishment types.  
Regulations and law governing marijuana businesses.  
Four town options.  
Marijuana industry nationwide.  
Case studies of other towns - bylaws examples and process models.  
Local impacts and controls.

### 2 Share Information on Businesses, Options and Process with the Townspeople.

### 3 Survey the Opinions of the Townspeople.

The survey sought to determine the townspeople's opinion on which, if any marijuana businesses they would like to have in town.

The survey questions and format were designed based on the 4 options available to the town.

Created paper and digital versions of same 7-question survey.

All survey responses - paper and digital - were treated anonymously.

Paper: 1,045 surveys mailed with a postage-paid return envelope to every voter.  
Surveys available at Town Hall.  
Surveys shared with community members.

Digital: Created surveymonkey.com replica of print survey available to take online.  
Links available in NM5VN, Maggies List, email blasts, town news and alerts.
