REQUIREMENTS:

1. Six (6) exact copies of application.
2. Six (6) exact copies of a site plan applicable to the site and use of said site for which a Special Permit is requested.
3. Six (6) exact copies of specifications necessary to further describe the site or use for which a Special Permit is requested. At least one copy of any maps being submitted be no larger than 11" X 17".
4. A fee of \$200.00 to cover the cost of the public hearing notices and the notification of parties in interest. If the cost exceeds \$200.00, the applicant will pay the balance due upon notification from the Granting Authority.
5. If the applicant and owner are different, a letter signed by the owner of the property shall be submitted with this form authorizing the applicant to apply for the Special Permit.
6. All site plans and specifications must be signed and dated by the preparer.
7. Prepare all the necessary papers, maps, etc. and bring to the Selectmen's Office. Please call for an appointment (413-229-8116) to return your completed Special Permit Application. This will allow ample time for your Special Permit application to be reviewed to see if it is complete. Also, the dates for your public hearing before the Board of Selectmen and your schedule of meetings before the Planning Board, Conservation Committee and Board of Health will be set at this time.
