The Board met with Highway Superintendent, Charles Loring to review and discuss the potential design and engineering plans for the Clayton Mill River Culvert. The discussion confirmed the plans should be designed to meet the current state stream crossing standards and meet all DEP regulations. The Board will meet with Foresight Engineer, Steve Mack at its meeting on July 1, 2013. The current plan is to carry FY13 funds forward from roads and bridges to use towards engineering.
