Rebecca Schreiber -Research 112 provisional applications, yet only 3 research applications.

No one is licensed as of yet in the Commonwealth.there are three applications. But there are huge hurdles, legally . There is no modeling.

Bill Kelly testing – 4 testing labs in State.

Lot of push back from growers and retailers that the government is not licensing these testing facilities as of yet, and no retailer or grower may sell their products without lab approval. Labs will be testing product for potency, heavy metals, etc

Sandra Walker – Micro business.

To provide small businesses in the commonwealth the ability to compete. There is a company, Sira Excelerate is offering to train for a micro business, a twelve week program.

Eric Shaefer – Craft co op presentation .Facility can grow up to 100,000 square feet. Many growers. Share overhead and requirements. May also manufacture. Co owned by all growers and manufacturers,

Cultivator -Three types - full outdoor, greenhouse model, indoor – usually a repurposed factory, or building. Discussion of vertical growing.

Start up costs -tier one ground up indoor facility \$1,000,000. Tier 11 greenhouse would be the same price.

Discussion of property tax, for such a facility.

Estimate for labor. Outdoor 6 to 100 employees depending on size.20.00 per hour for pickers is estimated.
