The meeting was called to order at 7:02 p.m.

## Review with Alana Chain the Altus Power Solar Field (Park Avenue)

Alana advised the Board that she invited the Conservation Commission, as well as the Planning Board, for an on-site visit who be given the opportunity to ask any questions. The Board decided to meet with Alana on Monday, December 20, 2021 at 3 p.m. for a site visit. The Board will meet at Town Hall. Alana is sending drawings, etc. to the Building Department.

Bob discussed battery storage and containment systems with Alana, as technology has changed since the start of the Park Avenue project. Alana stated that the inverters are akin to a shipping container that house all the safety features. Alana advised the Board that there is a fire suppression system for the equipment on site. The Fire Chief will need to approve the site prior to it being operational.

It was felt that additional information is needed on containment systems and batteries as well as the fire suppression system. This will be put on future agendas for discussion.

There are two locations that consist of the solar field(s), i.e. 646 Mill River Southfield Road (15 acres) and 540 Mill River Southfield Road (4-5 acres).

• Solar field Bylaw for Village District and Noise Reduction – The Board will look at noise restrictions from other towns. Mark advised that the noise level increases when there is

increased sunshine. He felt the bylaw had to be tweaked after additional information gathered on new technologies and noise levels.

- Flow Chart for New Construction Mark and Sharon is working on the flow chart.
- Riverbank Remediation It was agreed that the Riverbank Remediation is not part of the Planning Board's purview and should be referred to the Board of Selectmen.
