Pursuant to Purpose 7 of the Open Meeting Law (M.G.L. c.30A, §21(a)(7)), to comply with or act under the authority of, any general or special Law or federal grant-in-aid requirements. specifically M.G.L. c.30A, §22 regarding the review and approval of executive session minutes, to consider the approval and release of executive session minutes from October 23, 2019; October 24, 2019 and November 5, 2019 and also pursuant to the purpose(s) for such executive session(s), being Purpose 1 (M.G.L. c.30A, §21(a)(1)) to discuss the reputation, character, physical condition or mental health, rather than professional competence, of an individual, or to discuss the discipline or dismissal of, or complaints or charges brought against, a public officer, employee, staff member or individual; and Purpose 3 (M.G.L. c.30A, § 21(a)(3)) to discuss strategy with respect to litigation in DeGrenier v. Southern Berkshire Regional School District et al.; and Purpose 1 (M.G.L. c.30A, §21(a)(1)), to consider Open Meeting Law complaints against public officers, namely the members of the School Committee, such complaints having been filed with the District by Jennifer Brown on October 18, 2019; and October 24, 2019; and Purpose 2 (M.G.L. c.30A, §21(a)(2)), to conduct strategy sessions in preparation for negotiations with nonunion personnel or contract negotiations with nonunion personnel and not to reconvene in open session; and Purpose 7 (M.G.L. c.30A, §21(a)(7)) to comply with or act under the authority

of a Massachusetts General Law by receiving legal advice from counsel protected from disclosure under Massachusetts General Law with the relevant citations of law being M.G.L. c.4, §7(26); M.G.L. c.30A, §21(a)(1); and M.G.L. c.214, §1B, as an open meeting may have a detrimental effect on the litigating position of the public body, as declared by the chair; and not to return to open session.
