Update on COVID-19 (Coronavirus) and Local Boards of Health (LBOH)

Please note: This is a rapidly evolving situation. Cases continue to rise in Berkshire County, although the rate of rise is flattening, and all non-essential personnel should be staying at home except for essential services. BCBOHA will continue to provide updates and coordinate public messaging on the situation on a regular basis. Please share this information with your other municipal officials, boards and departments.

#### **Latest News:**

#### **Non-COVID Emergency and Urgent Medical Care**

Local reports, as well as reports from other parts of the county and around the world, suggest that people with emergent medical conditions not related to COVID-19, including heart attacks, strokes, appendicitis, diabetes complications, gall bladder inflammation and other conditions are not seeking medical assistance in a timely manner. Members of the public should be encouraged to seek emergency and urgent medical care if needed from their providers and local hospitals. Protocols to protect the safety of non-COVID patients are in place, and members of your community should be encouraged to seek care if and when it is needed.

If you received a public information request to release town-specific COVID case numbers for your community, please note that that request has been withdrawn due to the DPH releasing town-based data. #### Masks Received between 4/4 and 4/10 from DPH

Note that some masks received from DPH between 4/4 and 4/10 did not meet the standards of a N95 respirator mask, despite labeling suggesting that they did so. The first type of mask, the SDI respirator mask demonstrated a filtration level above 90%. If you do not have access to N95 respirators then you can consider using these masks as an alternative. The second type of mask, labelled "KN-95 Disposable Face Mask" in white packaging demonstrated a lower filtration level when tested. Accordingly, the DPH recommends that these products should be used as a facemask only.

#### **Extension of School and Non-Emergency Childcare Facility Closures**

The Baker Administration announced on April 21, 2020 an extension of the closure of all public and private schools in the commonwealth through the end of the school year, and an extension of the closure of all non-emergency childcare programs until June 29, 2020. Emergency Child Care programs approved by the Department of Early Education and Care (ECC) will continue operating. In addition, ECC and Care.com have partnered to assist currently unemployed childcare workers and families to provide skilled in-home care. #### **Advisory Regarding Face Coverings and Cloth Masks**


The Baker Administration released guidance for the public regarding the use of face coverings and cloth masks to help prevent the spread of COVID-19 on April 10, 2020. Face coverings are defined to include anything that covers a person's nose and mouth, including dust masks, scarves, and bandanas, and people are advised to use these coverings in situations where it is difficult to maintain a social distance of six feet from others such as at the grocery store or pharmacy. People are also advised specifically to not use healthcare worker masks such as N-95s that should be preserved for use by healthcare workers. ## **Partners in Health Community Tracing Initiative (CTC)**

The Baker Administration is partnering with Partners in Health to develop a state-wide strategy to address the increasing need for assisting municipalities with contact tracing of COVID-19 cases and contacts. By May 1 it is expected that all municipalities will be connected to the CTC. Current plans are to allow local Public Health Nurses until midnight each evening to claim cases; unclaimed cases or cases where assistance is requested will then automatically go to the CTC for follow-up. A diagram of the timeframe for the rollout of the CTC is below. If it works as planned, this initiative will be an important surge capacity partnership with local boards of health for case investigation and contact tracing, which will hopefully help keep the number of new cases lower and allow the state economy to open up sooner.





#### **Grocery Store Guidance**

Further guidance on the operation of grocery stores was provided by the Department of Public Health and Baker Administration on April 7, 2020 to reduce the exposure of shoppers and employees to COVID-19. New guidelines place a stricter maximum on store occupancy at any point in time, limiting

store occupancy to 40% of its maximum permitted occupancy level on record with the municipality. This occupancy includes shoppers and employees of the store. Updates regarding enforcement and guidelines are expected from the State DPH.

#### **Campgrounds / RV Parks**

The state has clarified that RV Parks which house people year-round are considered essential and may stay open. People who live there year-round may continue living there. However, campgrounds/RV parks, etc., that are only open seasonally are not considered essential and may not open. This includes situations where people rent the space year-round and leave a vehicle there in the off-season. These are not considered second-homes and the sites may not be opened for the season until the order on non-essential businesses is rescinded. BCBOHA released updated guidance to LBOHs on April 10, 2020 and plans to release a BOH Job Aid in the near future via the BCBOHA list-serv.

#### **Essential and Non-essential Services:**

The state has a continuously updated list of specific questions regarding what services are or are not considered essential. #### **Expansion of Resources for Health Care Providers and Long-Term Care Facilities**

The state, in conjunction with the National Guard has rolled out a program to test residents and staff of long-term care facilities. In Berkshire County, Berkshire Health Systems, in conjunction with County Ambulance, has agreed to take on this role, and can be contacted to conduct testing in any long-term care or other congregate living facility. This allows facilities in Berkshire County to be tested on a more timely basis.

#### **New Data Reporting from DPH**

The DPH Covid-19 webpage is now providing case data broken down by city/town updated every Wednesday. This change in publicly displaying case data by city/town reflects requests made by individuals across the Commonwealth as well as the increase in testing and data available to the state. Case data will only be available by municipality if there are five or more cases per 50,000 residents in order to maintain privacy of patients. Please note that these are the cases reports according to DPH records; occasionally this may differ from municipal reports due to confusion on addresses (particularly where towns share a common zip code) or where someone is incorrectly reported in a municipality they do not live in. In addition, DPH is now providing patient census by hospital daily. 

#### **Updated Guidance for Discontinuation of Home Isolation**

Revised guidance for discontinuation of home isolation was released on April 2, 2020. Currently, there are two approaches for discontinuing home isolation. The non-test-based approach states that individuals with COVID-19 who have symptoms and were directed to care for themselves at home may discontinue home isolation under the following conditions: at least 3 days (72 hours) have passes since recovery, defined as resolution of fever without the use of fever-reducing medications **and** improvement in respiratory symptoms; **and**, at least 7 days have passed since symptoms first appeared. The second approach is a test-based strategy for individuals with COVID-19 who have symptoms and were directed to care for themselves at home. These individuals may discontinue home isolation under the following conditions: resolution of fever without the use of fever-reducing medications **and** improvement in respiratory symptoms **and** negative results for COVID-19 from at least two consecutive nasopharyngeal swab specimens collected >/= 24 hours apart (total of two negative specimens). Note that those who were asymptomatic upon testing positive should still isolate for 7 days following the positive test.

#### Weekly Conference Calls for Local Boards of Health and the State

DPH continues to hold weekly calls with local boards of health across the Commonwealth on Tuesdays at 3:00 PM. These calls have DPH staff from a variety of departments available for answering questions including Epidemiology, Emergency Preparedness and Environmental Health. The number for this call is 888-390-5007 and the participant code is 6137873.

The Governor's Command Center also holds a weekly call for the LBOH every Friday at 9:00 AM. Boards of Health are asked to only have one person dial in as phone lines are limited. Dial in information is: 888-390-5007 with Passcode 4847016.

In addition, DPH has been holding a weekly call related to MAVEN that the public health nurses have been participating in.

#### **Information for Local Boards of Health**

DPH also holds weekly conference calls for Local Boards of Health on Tuesdays at 3:00 PM. Dr. Dan Doyle from Berkshire Medical Center and the Dalton BOH is also holding weekly conference calls with the LBOH of Berkshire County, especially the medical personnel who are also on Boards of Health and chairs and other representatives.

#### **Emergency Sheltering in Berkshire County**

MEMA has recently contracted with the Hilton Garden Inn on South Street in Pittsfield to provide non-congregate housing for COVID positive homeless individuals. Additional sites are opening across the state. In addition, the former St. Joe's school has been retrofitted as a shelter for homeless individuals and is now operational. It is being operated by Service Net with medical assistance from Community Health Programs (CHP) and also contains locations suitable for quarantined individuals.

#### Hotel/Motel and Short-Term Rental Guidance

In addition to the updated essential businesses list, the Department of Public Health released new guidance on March 31, 2020 regarding the operation of hotels, motels, inns, bed and breakfasts, and other short-term residential rentals. The guidance states that hotels, motels, and short-term rentals may only be used for efforts related to fighting COVID-19, such as housing front line health care workers or individuals, or for Massachusetts residents who have been otherwise displaced from their residences. #### **Public Health Advisory**

On March 24, 2020 the MA Department of Public Health issued a public health advisory strongly urging those who are 70 years and older and those with underlying health conditions to stay-at-home with the exception of essential trips for food, medicine, and focused time for exercise and fresh air. Those not providing essential services are also strongly advised to stay at home at this time to help protect those who are providing essential services. The DPH also urges keeping at least six feet between individuals who do not live in the same household at all times. Grocery stores and pharmacies must provide at least one hour per day for shoppers 60 years of age and older. Additionally, these establishments must include strategies to reduce COVID-19 exposure to their employees, including access to handwashing facilities, alcohol-based hand sanitizers, disinfecting wipes, and procedures to ensure both employees and customers remain at least six feet apart at all times. Employees who are sick should not report to work and if they do come to work they must be sent home. #### **Traveler Quarantine**

The Federal Government has recommended that all those leaving New York for other locations self-quarantine for 14 days as a precaution. Berkshire municipalities with large numbers of second-home owners should be aware and pay attention to short term rentals and hotels. This guidance will be displayed as posters at service plazas along 1-90 eastbound, distributed as flyers at major transportation hubs and on posted on highway message boards. Visitors are instructed not to travel to Massachusetts if they are displaying symptoms. Health care workers, public health workers, public safety workers, transportation workers and designated essential workers are exempt from this requirement.

#### **Personal Protective Equipment (PPE)**

Personal Protective Equipment (PPE) such as masks, gowns, eye shields and gloves remain in short supply throughout the Commonwealth and the country. On March 29, the Baker-Polito Administration announced an online portal where individuals and companies can donate or sell personal protective equipment (PPE) and volunteer to support the COVID-19 outbreak in Massachusetts. This portal allows companies and organizations to sell or donate protective equipment that is in short supply and is expected to bolster current efforts to leverage traditional and emergency supply chain channels. The program also provides an entry point for local manufacturers to get more information on adapting their businesses to produce more equipment in Massachusetts, an effort being led by the administration's recently established Manufacturing Emergency Response Team.

For providers and responders looking for PPE, currently, PPE requests for health and public health are going through the Health and Medical Coordinating Coalitions (HMCC) while those for public safety and first responders are being directed through MEMA.

## **Funding Update**

The Baker-Polito Administration has made money available to local municipalities to address public health costs incurred in responding to this outbreak. Funds will flow directly to the 14 largest cities in the state (only Springfield in Western Mass) and through the 15 existing health districts known to DPH, including the Berkshire Public Health Alliance and Tri-Town Health in Berkshire County. Municipalities that do not fit into either category will be aligned with a regional entity across the state, including several regional planning agencies, MHOA and MAHB. In Berkshire County, if your town is not part of either district, you will be aligned with Berkshire Regional Planning Commission. Money has begun to go out to municipalities that have expressed need. If you have received an Agreement, as soon as that signed agreement is returned the check will be sent. If you have not yet received an Agreement, and have financial needs that fit with the guidance, please contact us as soon as possible. Allowable expenses include: Surveillance and case identification (including, but not limited to, public health epidemiological investigation activities such as contact follow-up), monitoring of travelers, Public Health Nurses, data management, isolation and quarantine (including, but not limited to, housing; wrap-around services; security; environmental control, clean-up and waste management; and behavioral health services), surge public health staffing, risk communications support, public health coordination with healthcare systems. Non-applicable funding areas include City/town municipal activities (law enforcement etc.) and food and other sundries.

In addition, significant federal funding is expected in Massachusetts by April 24, 2020 due to the CARES Act. This funding will include funding for municipal operations, including first responders, among other eligible expenses. More information will be provided as it becomes available.

#### **Housing Inspections**

Given the State of Emergency, the LBOH has discretion to delay non-emergency inspections. Inspections should resume as normal at the termination of the State of Emergency.

#### Food Inspections

A LBOH has discretion to decrease the frequency of food inspections under the retail food code. (105 CMR 590.008(H); FC 8-401.10.) During the declared State of Emergency, LBOH are not required to submit a risk-based facility inspection plan for approval. The Food Protection Program will provide technical assistance to review any emergency inspection plans for LBOH, upon request.

All food contact surfaces, equipment, and utensils used for the preparation, packaging, or handling of food products must be washed, rinsed, and sanitized before each use. Additionally, food establishments are strongly urged to frequently clean non-food contact surfaces, such as doorknobs, tabletops, chairs and menus. Additional guidance on inspecting food establishments has been sent out under separate cover.

Note that when food establishments closed due to COVID begin to reopen, pre-opening inspections are at the local Board of Health discretion and are not required.

#### Swimming Pools & Adult Tobacco Establishments

Swimming pools, adult tobacco establishments are not considered essential services and must be closed.

#### **COVID-19 Testing in Berkshire County:**

The drive-through testing facility at Berkshire Medical Center is currently operational. All testing requires a physician order. Symptomatic individuals may call the BMC hotline at 855-BMC-LINK, OR 855-262-5465. After hotline screening, those qualified will be referred for a telemedicine appointment with a physician, and if appropriate, given an order and a time for testing.

#### **Berkshire County Emergency Operations:**

The Northern Berkshire Operations Center, the Southern Berkshire REPC, and the Central Berkshire COVID-19 Coordinating Center are activated, and jointly working together to address needs across the County.

#### **COVID-19 Response Command Center**

On March 14, the Baker-Polito Administration announced the creation of a new COVID-19 Response Command Center. Secretary Marylou Sudders is leading the cross-secretariat response to the outbreak. The Command Center is the Commonwealth's single point of strategic decision making and coordination for the Administration's comprehensive COVID-19 response.

#### Calls to your BOH

If your BOH receives a call from someone experiencing respiratory symptoms or if a provider in your area receives a call from someone experiencing symptoms, please call the Massachusetts Department of Public Health (MDPH) 24/7 Epidemiology line at (617) 983-6800 for assistance and the latest recommendations for managing a Person Under Investigation (PUI). Individuals experiencing symptoms of a respiratory illness can also call the Berkshire Health Systems Hotline at 855-262-5465 between the hours of 7am and 7pm, 7 days/week.

#### **Questions from the General Public and Worried-Well**

The Massachusetts Emergency Management Agency (MEMA) and United Way 211 call and information service is now operating 24/7, and is answering calls for community members who are not sick, but would like to receive information related to COVID-19. Residents across the state can also sign up for the new text notification system including updates, news and prevention information by texting COVIDMA to 888-777. Also encourage your residents to sign up for your municipalities outgoing-911 alert system (such as code red or similar).

On March 24, 2020 the Berkshire Eagle published an open letter from the Mayors of North Adams and Pittsfield, Berkshire Health Systems and BCBOHA for the 32 local boards of health urging all residents to stay at home as much as possible to slow the spread of COVID-19. #### **Local Schools and School Closings:**

The Governor has ordered all schools closed until May 4, 2020. Many schools started on-line learning this week. Food for those who ordinarily receive free or reduced school breakfast or lunch is available in many municipalities. Child-care facilities, unless they are serving essential workers, are also closed.

#### **Situation Report:**

Recently, a new strain of coronavirus—2019 Novel (new) Coronavirus (COVID-19)—was detected in Wuhan, China. This novel coronavirus causes a respiratory (lung) infection. This new virus is related to, but different from, other coronaviruses that cause the common cold and diseases such as SARS and MERS. Common symptoms of COVID-19 are fever, cough, shortness of breath and in severe cases, pneumonia (fluid in the lungs). Cases range from very mild to severe.

As of April 26, there have been 54,938 confirmed cases of COVID-19 in Massachusetts, of which 428 are in Berkshire County. Although Berkshire County has a high number of cases per capita, for the past couple of weeks, the number of cases has been rising more slowly than in other parts of the state. There are signs that the number of cases is flattening throughout the state at this time, although it is still too early to say if the peak has passed. The number of people tested in Massachusetts has increased to approximately 236,100. There have been 2,899 deaths in Massachusetts. There have been 928,619 reported cases in the United States as of April 25, and 52,459 deaths. New York continues to have the highest number of cases. Racial and ethnic disparities are apparent in the deaths and serious illness reported. Almost all countries across the globe have seen at least one case.

#### **Non-Pharmaceutical Interventions (NPIs):**

The CDC is recommending personal preparedness and protective measures, including Personal Non-Pharmaceutical Interventions (NPIs). NPIs are measures taken to help prevent the spread of diseases that do not include medications. Currently, there are no medications or vaccinations available to prevent COVID-19, however, everyone should practice these respiratory illness prevention protocols:

- diligent hand washing with soap and water for at least 20 seconds
- avoid touching your eyes, nose and mouth with unwashed hands
- cover your mouth with a tissue when coughing or sneezing
- stay home from school, work and other people when you become sick with respiratory symptoms like fever or a cough
- avoid close contact (within 6 feet) of people who are sick

- if you are over the age of 60 or have underlying health conditions you should stay home as much as possible.
